Long-Term Vision Activity

"Imagine Scott County in 2040. What does it look like?"

Visioning ideas were categorized and written on paper on the walls for everyone to see. The goal was to encourage attendees to share their long-term vision for Scott County, including:

1. Wants, needs, etc.
2. What's missing in our community that you'd like to have?
3. Categorize comments as physical/environmental, social, or economic

The comments below were submitted under the categories of Physical, Social, and Economic. They were then assigned to subcommittees based on their best fit. Some comments are listed under multiple subcommittees due to their complex nature.

Physical

- Stone fences maintained & enhanced
- Keep development near city & leave lots of open country
- Well-farmed landscape
- No more cluster subdivisions with beige houses

Social

- Recreational Lake in north for camping & tourism
- Continuing heritage of small churches throughout county

Economic

- More Community Supported Agriculture in the county
- Bigger, more festive farmers market
- Curb recycling for city residents
- Homestead economies
- Limit commerce to homesteaders' surpluses, localize commerce (see Comp. Plan 1991 Vol.2 P.8 Sec 5.3.2, Agriculture)
- Every citizen a farmer

January 26, 2016**

Growth Management Activity

“We’ve had a rapid annual growth rate and are expected to reach a county-wide population of 100,000 people by 2040 (twice our current pop). What do we need to be doing to prepare for that kind of growth?” Participants were asked to write responses on post-it notes to place on the wall. After the meeting, the comments were assigned to subcommittees based on their best fit. Some comments are listed under multiple subcommittees due to their complex nature.

- Expand emergency services especially in rural areas
- Re-establish riparian zones back to native plantings
- Infrastructure planned & implemented with a green focus

Draft Vision Statement – Agriculture & Environment:

Agriculture and environmental protection provide Scott County with a sustainable and vibrant future. Prime farmland and environmentally sensitive areas are protected and preserved from sprawl and development. Scott County agricultural areas provide access to locally grown and produced goods. Recycling, re-use, and composting reduce waste and demand on natural resources.

Draft Fundamental Principles – Agriculture & Environment:

- Development outside of the urban service boundaries should be at a scale appropriate for the density and character of the rural landscape.
- Water quality can be affected by all land use and development activities. Water resources are interconnected with all other aspects of the environment and are important aspects of land use and development and review.
- Environmentally Sensitive Areas include: creek conservation corridors, property zoned C-1, minor waterways, Scott County reservoir protection area, aquifer recharge area, wetlands, significant trees and fence rows, steep slopes and clay soils, sinkholes, cave areas, major rock formations and outcroppings, springs, floodplains/floodways, landfills/refuse areas, prime farmlands, significant natural habitats for plants and animals, and scenic and historic rural resources.
