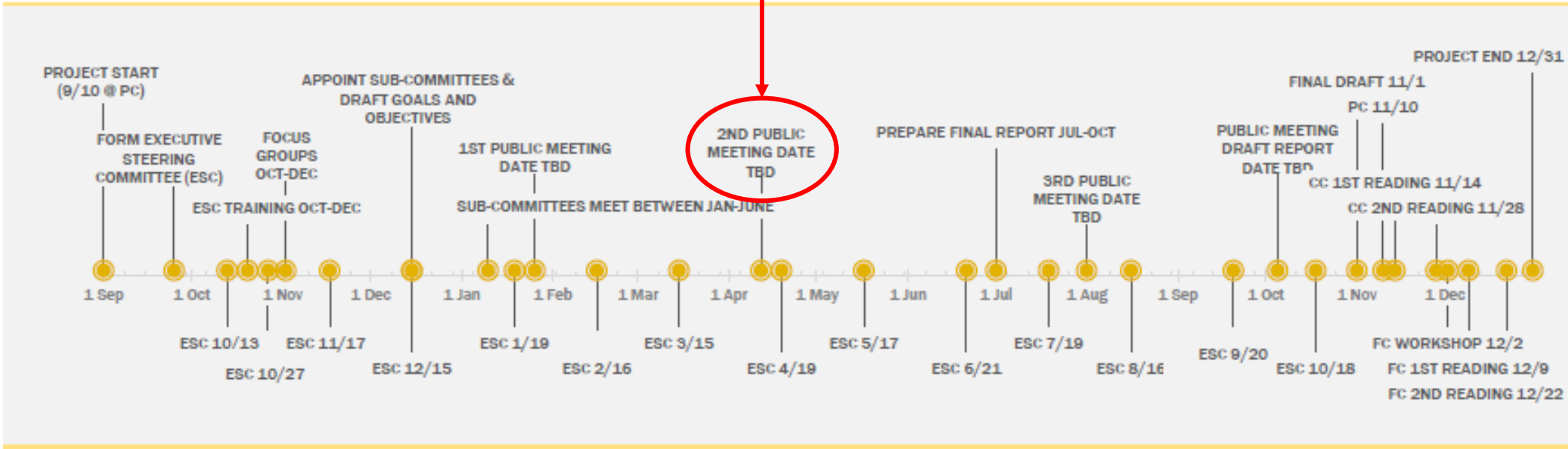

WORK PLAN

June

1. Public Meeting #2 – June 14, 2016

July

1. Continue review of other committee goals and action items

2. Staff will conduct housing chapter research

August

1. Housing Research
 - a. Affordability, availability/vacancy, lot counts, rental inventory, age, condition

 - d. Flexibility in the Zoning Ordinance

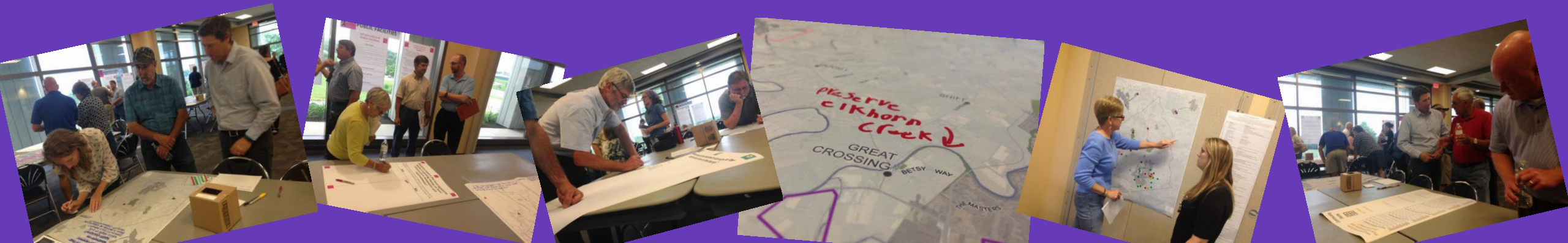

JUNE 14TH MEETING FEEDBACK: **HOUSING GOALS & ACTION ITEMS** COMMENTS RECEIVED

- Use funds (similar to PDR) to purchase lands for parks and open spaces that can be used by the public, rather than only private land owners. Not just visual, usable public benefits.
- Highly in favor of a local authority inspecting rental properties for sub-standard living conditions.
- Goal: Coordination of schools (including pre-schools) with planning of housing and major subdivisions.
- Goal: Transitional housing zoning linked to employment, schools, and shopping access.
- Incentives for small/local developers? (More small, incremental development, capture demand from Fayette County pressures)
- Use PUD's around public projects like the Legacy Trail so developers can still get full potential from the land, while contributing to ROW acquisition and improved facilities.
- Allow/encourage co-housing developments.
- Neighborhood Centers, Parks, and services.

JUNE 14TH MEETING FEEDBACK: **HOUSING SURVEY**

Question:

“What price point does affordable housing mean to you?”

We gave 30% of household take-home income as a standard measure.

Reponses (4):

- 30% is too much, should be about 25%

“Do you think we have enough affordable housing within our community?”

Reponses (4):

JUNE 14TH MEETING FEEDBACK: **HOUSING SURVEY**

Question:

“Is there a certain type, size, or price of housing that you feel we need more or less of in our community?”

Reponses (4):

- More rental units
- More livable community of small homes for retirement, 2 bed rooms
- Quads? With low yard maintenance, etc. having contractor maintain lawns.
- Rentals – developments for future homes

JUNE 14TH MEETING FEEDBACK: **HOUSING SURVEY**

Question:

“What is the maximum distance you want to live from...?”

Reponses (4):

Grocery	Neighborhood Park	Restaurant/Retail
9 miles	8 miles	10 miles
1 mile	1 mile	1 mile
1 mile	1 mile	1 mile
5 miles	10 miles	5 miles

- Others listed: Community garden, covered picnic area, sidewalks, walking trails

JUNE 14TH MEETING FEEDBACK: **HUMAN SERVICES GOALS & ACTION ITEMS** COMMENTS RECEIVED

- We need a mental health awareness day for Georgetown/Scott County. Include when to get help (aggression or suicide). Have a mental health professional there.
- Address growing drug use in community – meet with local police/sheriff's office to gather info for next 5 years – need for plans to help address addiction in community. (Anne Huber)
- Required employability with training assistance to transition from public assistance.
- Goal: Full employment for able body citizens.
- Goal: public assistance require training & employment timeframe for self-sufficiency.
- No soft skills being taught.
- Not educating students for entry level labor.
- No “Work based” training program at school (not co-op)

JUNE 14TH MEETING FEEDBACK: **HUMAN SERVICES-RELATED QUESTION**

Question:

“How can we build social capital and increase civic involvement?”

Reponses:

- Try to build a community school program for volunteering (k-12, college). Maybe class credit for volunteering?
- Internship programs with non-profits, for class credit.
